**MINUTES:** The minutes of the meeting held on the 20<sup>th</sup> January 2016 were approved and signed as a true record.

## **MATTERS ARISING:**

**Maintenance:** Flooding - Junction of Burton Fleming Road with Gosling Slack. The Clerk had contacted Highways a number of times regarding this issue. Council operatives had finally attended and carried out work on the morning of 2<sup>nd</sup> March, which it is hoped will resolve the problem.

**PARISH COUNCIL WEBSITE:** As agreed at the meeting on the 7<sup>th</sup> October 2015, the grant application for the purchase of a computer and printer/scanner for the Parish Council had now been submitted to the NALC via ERNLLCA. This grant application document was duly approved.

To date, there had been no further developments regarding the setting up of the new Council website by the East Riding of Yorkshire Council, but they had confirmed receipt of the application and that it would be attended to in due course.

**PIT SITE GRAZING LICENCE** The Clerk reported that the Council had received one tender for the 364 day grazing licence for the Pit Site which is available from the 24<sup>th</sup> March 2016. The tender came from the current licence holder, Mr R Garbutt, offering the sum of £100 for use of the land to graze sheep. It was noted that, previously, Mr Garbutt has maintained and secured the site well, therefore it was agreed that he be offered the grazing licence for the period 24<sup>th</sup> March 2016 to 22<sup>nd</sup> March 2017 inclusive at the said sum of £100.

**ANY OTHER BUSINESS:** The Clerk advised that she had received up to date details of the community policing for the area, including e-mail details for individual officers. The local team is based at Bridlington Police Station.

Cllr J Taylor expressed concern that a deep pothole in Mere Lane was becoming difficult to avoid. It was suggested that this be notified via the ERYC website. Mrs Taylor will try telephoning the Council to get some urgent action
